Subject: Extension of Provisional Affiliation of said School beyond 31.03.2019-reg.

Sir/Madam,

This is with reference to inspection of your school conducted by the Inspection Committee on 24/05/2019. In this connection, I am directed to inform you that on perusal of the Inspection Report and the documents enclosed with it, certain deficiencies have been observed as under, which must be removed by the school :-

1. On scrutiny of inspection report of the school, no prescribed inspection fee of Rs. 50000/- has been found to be deposited by the school **Inspection fee** is required to be remitted separately apart from submission of online application fee remitted by the school while applying online for extension of affiliation in June 2018. Hence, the school is required to remit the prescribed Fee of **Rs.50000/-** through Demand Draft in favour of Secretary, CBSE, payable at Delhi, towards periodical inspection.
2. The number of students enrolled is **more than 40** in some sections (Sr Sec level). Therefore enrolment should be restricted with optimum number of 40 students per section as per norms of the Board.
3. School has enclosed a lease deed dated 29-12-2017 of total area of 4620 sq meters with Khasra Numbers 6635 & 6636 whereas land certificate dated 21-07-08 has been furnished for total Area of 8738 sq meters. The school is required to clarify the difference and furnish the land documents/lease according to the details given in the land certificate.
4. The school is required to appoint more **trained & qualified PRTs** to maintain section/teacher ratio 1:1.5 as per norms of the Board
5. The school is required to maintain Reserve Fund in the joint names of the Principal of the school & Managing/Trustee/Member of the society/trust, company etc. running the school concerned in the scheduled Bank and send a copy of the same.
6. School has furnished Building Safety Certificate from a Govt approved Architect in Certificate from competent **Govt. Authority**. Copy of license of the Govt approved Architect is also not submitted. Hence the school is required to furnish **Building Safety Certificate** issued by the competent Govt. Authorities (**PWD/Nagar Nigam**) or a valid certificate from govt approved engineer with valid / approved license copy may be submitted.
7. The school is required to appoint Special Educator as per rule 13 (11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
8. Wellness Teacher (**counselor**) and **PTI** are required to be appointed.
9. The school is required to forward a panel of 5-6 names of principals (at least 2 from KV/JNV) of Senior Secondary schools affiliated with the Board recommended so that 02 of them may be approved by the Board as its nominees in the School Managing Committee.


All the documents forwarded to the Board must be signed by the Principal and Manager of the school.
